NOTE: It is understood that in the ~~composition~~ of this scheme the process of "unification" is applied to the Stops of the Great and Pedal Organs, the Swell being normally constructed.

THIS AGREEMENT

Made this 31st day of May, A. D., 1917, between HILLGREEN, LANE & COMPANY, OF ALLIANCE, OHIO, of the first part, and Detroit-Colonial Theatre Company of Detroit, Michigan, of the second part.

WITNESSETH, That the party of the first part HEREBY AGREES to build an Organ according to the specifications annexed, and to erect the same in the Theatre of the above named Company at Woodward & Sibley Sts., Detroit, having it completed and ready for use on or about the 15th day of Aug. 1917.

Should said Organ, upon examination by a competent and disinterested expert selected by second party, be found not to accord with the specifications and terms of this agreement, said first party agrees, at its own cost and expense, to at once make good any defect, or failing in this, to remove said Organ from the building, and the party of the second part shall no longer be held by the terms of this agreement.

And said first party further agrees, at its own cost and expense, for the term of one year next after the completion of said Organ, to remedy any defects therein, resulting from the use of improper materials or from inferior workmanship.

And the second party hereby agrees to pay to HILLGREEN, LANE & CO., or to their order, the sum of Forty-five Hundred Dollars payable as follows: \$450.00 upon the signing of this agreement; \$1800.00 upon the completion of the Organ in the Theatre; and three lease notes as follows, stipulating that title and ownership of said Organ payable upon acceptance of Organ as follows: shall remain vested in party of the first part until all payments thereon are made.

- One note on 6 months for Seven Hundred and Fifty Dollars
One note on 12 months for Seven Hundred and Fifty Dollars
One note on 18 months for Seven Hundred and Fifty Dollars
Notes to bear 6 per cent interest.

And the party of the second part further agrees, that said building and Organ Chamber shall be in readiness for the erection, tuning and regulating of said Organ, including the conveniences of light, heat and power, and subject to the possession of representatives of the party of the first part for a period of 20 days next previous to specified time for completion of Organ.

And the party of the second part further agrees to have the Organ examined immediately on completion, so that the party of the first part, or its representatives, shall not suffer delay.

And the party of the second part further agrees to assume all risk of damage to said Organ, or parts thereof, when placed inside the building it is to occupy; and to receive the Organ upon its arrival, cart it to the building and pay the freight thereon, said freight and cartage to be deducted from the price of the Organ, and such reception and care not to be construed as an acceptance of said Organ.
