ADDENDUM to the Agreement dated February 25, 1976, by and between The Reuter Organ Company, Lawrence, Kansas, the Builder, and Pilgrim United Church of Christ, Cincinnati, Ohio, the Purchaser, witnesseth:

It is mutually agreed by both parties hereto that the following additions shall be made to the above-referred to Agreement:

1 set of 25 note Mayland Chimes with five point volume control, "prepared" for outside amplification.

Swell to Pedal 8' Reversible, toe stud only, (to be added to existing combination action).

In consideration for the above additions, the Purchaser agrees to pay to the Builder the additional sum of \$1,688.00, thus increasing the Agreement dated February 25, 1976 to \$19,458.00, plus any applicable taxes. This additional amount of \$1,688.00 shall be divided into two payments of \$844.00 each. The first payment of \$844.00 shall be added to the delivery payment of the original Agreement, thus making this payment \$7,952.00. The second payment of \$844.00 shall be added to the final statement, thus making the payment due upon completion \$3,510.00.

All other terms and provisions of the said Agreement shall remain unchanged.
