MEMORANDUM OF AGREEMENT

The party of the first part agrees to build for and install in the Inman Park Baptist Church, Atlanta, Ga., the following additions to the Reuter Organ now in said church;

- 1. A new and larger-scaled 4' Octave Register of 61 pipes designed to afford a better and more brilliant ensemble to the organ.
- 2. A new 8' Diapason Register of 73 pipes to be added to the resources of the Swell Organ, the said Register to be composed of the 61 pipes of the 4' Octave now in the Great Organ, to which will be added 12 new pipes at the bass end in order for it to have the necessary 8' pitch required of the Swell 8' Diapason.
- 3. The 16' Pedal Bourdon Register will be re-regulated to afford the proper balance to the increased power of the organ made possible by the above two changes in the roster of Stops.
- 4. All of the pipes that enter into this change in the Specification of the organ are to be voiced and regulated in conformity to the established principles of good organ building.

The party of the second part hereby accepts this contract and requests of the party of the first part to proceed with the work as outlined above and agrees to pay therefor the sum of Seven Hundred, Fifty and no/100 Dollars, (\$750.00) in funds as follows:

- a. Upon the signing of this contract the sum of Seventy Five and no/100 Dollars, (\$75.00).
- b. Upon the completion of the work the balance of said purchase price, towit, the sum of Six Hundred, Seventy Five and no/100 Dollars, (\$675.00).

The party of the first part agrees to execute this work on or about the date of September 1, 1950, subject however to delays not within the control of the first party.

This agreement is subject to the acceptance and approval by an executive officer of the said first party.
