

MEMORANDUM OF AGREEMENT made this                      day of February  
1918, by and between M. P. Moller of Hagerstown, Maryland, party  
of the first part and the trustees of the Lutheran Church of the  
Covenant, Brooklyn, New York, party of the second part.

WITNESSETH: That the party of the first part hereby agrees to  
sell the party of the second part a two manual pipe organ after  
the specifications attached hereto, to install the said organ in  
the Lutheran Church of the Covenant, Brooklyn, N. Y., complete and  
ready for use, with console placed at side of Altar and organist  
facing choir, every part guaranteed satisfactory in every respect.

It is mutually understood and agreed that the party of  
the first part is to use with the said organ, the casing and front  
pipes of the organ now in the church, also the motor and blower, &  
and all other parts of the said organ now in the church are to  
become the property of the party of the first part and to be re-  
moved by him.

In consideration of the above, the party of the second  
part agrees to pay to M. P. Moller or his order the sum of twenty-  
five Hundred Dollars, and interest at the rate of five per cent  
per annum. Interest is to be paid annually with as much of the  
principal as possible, with the understanding that the entire  
amount is to be paid within five years from date of completion of  
organ in the church.

The party of the second part agrees that the said church  
will be in proper condition for the installation of the organ, and  
that the representatives of the first party may have suitable con-  
venience and opportunity for the installation of the organ, also  
to provide such conditions as necessary for the proper tone reg-  
ulation and tuning of the instrument, also necessary light, heat  
and power.

The party of the second part also agrees to do any  
cutting in the building which may be necessary for connecting  
the said organ and blower if such should be necessary, also any

ready for use, with console placed at side of Altar and organist facing choir, every part guaranteed satisfactory in every respect.

It is mutually understood and agreed that the party of the first part is to use with the said organ, the casing and front pipes of the organ now in the church, also the motor and blower, & and all other parts of the said organ now in the church are to become the property of the party of the first part and to be removed by him.

In consideration of the above, the party of the second part agrees to pay to M. P. Moller or his order the sum of Twenty-five Hundred Dollars, and interest at the rate of five per cent per annum. Interest is to be paid annually with as much of the principal as possible, with the understanding that the entire amount is to be paid within five years from date of completion of organ in the church.

The party of the second part agrees that the said church will be in proper condition for the installation of the organ, and that the representatives of the first party may have suitable convenience and opportunity for the installation of the organ, also to provide such conditions as necessary for the proper tone regulation and tuning of the instrument, also necessary light, heat and power.

The party of the second part also agrees to do any cutting in the building which may be necessary for connecting the said organ and blower if such should be necessary, also any necessary electric wiring to motor starter.

It is mutually agreed that the title and ownership of the organ shall remain with party of the first part until the contract price, before mentioned, has been fully paid after which

the instrument shall become the property of the party of the second part, also that all verbal agreements and understandings are merged in this contract, and the specifications attached hereto.
